Shared Services Collaborative

Implementation of the Collaborative began in January with an assessment or "check up" of each monastery's administrative operations, conducted by BMT for the purposes of identifying needed services. Assessment results support communities' needs for services requested in three main categories: financial services; benefits management; and information technology. These are some of the services that will be available through the Collaborative in the initial implementation phase.

The Collaborative has also entered into a relationship with a professional archivist, whose services are available to the communities on a consulting basis. The archivist is in the process of drafting an Archival Processing Manual for CCA. When it is complete, we will be inviting interested sisters to review and provide feedback on the draft.

Contracts for the services to be offered are in process. Work is underway to define terms and establish rates for the proposed shared services; arranging informational meetings between SSC members and CBS representatives; and getting help on an ad hoc basis for those communities with immediate needs for service.
