My first experience of CCA, as a novice at the 1999 General Assembly, was the surprise I felt at being allowed to attend, and the encouragement I was given to actively participate in the meeting. This openness to the concerns and ideas of all members of the association, not just prioresses and those in leadership, is one of the hallmarks of CCA. Fortunately, through the generosity of our donors, we continue to physically meet for our General Assembly every two years and have also been able to utilize Zoom technology to continue to gather real-time input from those members unable to attend in person. As the situations change, this becomes even more important for our future as an Association.

During my tenure on the Leadership Team the major thrusts of our efforts have been to continue providing ways for our membership to interact, grow spiritually and support each other in these rapidly changing times. Both Monasteries, some of which have had to close, and individual Carmelites, who have been displaced, have needed assistance in dealing with the issues brought about by changes in circumstances and directives coming out of Rome. Again, through the generosity of our donors, the Leadership of CCA has been able to visit and assist sisters in transition and engage people who are helping us to adjust to our new reality and look to the future.

Another thing your donations assisted with was the much needed updating of our CCA Webpage at httsp://ccacarmels.org. Though there is still work that needs to be done, we have launched the new site. A few of the highlights you might enjoy are:

### CCA General Assembly Session – May 2025

CCA currently holds a General Assembly every two years at which we elect going forward leadership and make other decisions. This year's Assembly has been prefaced by a series of discernment retreat days held via ZOOM under the direction of Sr. Nancy Schreck, OSF, focused on discerning possible options for the future governance of CCA. Additionally, a virtual pre-session of the meeting will be held in April at which the Leadership Team will provide accountability of their service over the past two-year term. Other topics will include reporting on CCA's financial status, the overhaul of the CCA website and its functionality for membership, and a brief report from the On-going Formation team. At the GA itself, Sr. Nancy Schreck, OSF will guide the Assembly through its on-going discernment. The prioresses of the CCA communities will account for their completion of Goal 5:

Each CCA community has adopted the protocol/practice of documentation in each of the areas as recommended by the task force and will have such in place within the next two years along with a process to keep current. Note: These areas include Legal, Financial, Medical, Archives, Sisters' Personal Documents, Building and Property, etc.

Additionally, Sister Mary Elizabeth of the St. Joseph Association is representing the US as a member of the international commission that is working on the updating of the Constitutions of the Discalced Carmelites Nuns. She will be presenting on the work of the commission and soliciting further input from the sisters.

The Assembly participants and delegates will then discuss proposals that have emerged regarding: *Goal 6: We have explored and proposed options for the future functioning of the CCA by the end of the upcoming tenure.* 

It is our hope and prayer that this Assembly will be graced with God's wisdom for making good decisions regarding CCA governance for the next two years.

#### And finally, a Prayer

Even in this penitential season of Lent, we celebrate the lives of the Saints, those who have gone before us and continue to bless us with their example and affection. We remember those holy people who have inspired us and continue to nurture our faith. In March, we celebrate the life of St Patrick and a few days later, we celebrate that quiet man, St Joseph, who loved and cared for Jesus and Mary, and now watches over the Church and all its members. Some days after the feast of St Joseph, comes the feast of the Annunciation, when we reflect on Mary's consent to be the mother of Jesus. Our Lady holds a prominent place in our hearts and liturgy, and we rejoice in her special care for us, the brothers and sisters of Jesus!
