#### Sunday- May 4 at 7:15 pm

The meeting opened, Sunday evening May 4 with prayer, a welcome to those attending in person as well as those on line and introductions by Sr. Colette.

Stephanie shared a slide focused on *Meeting agreements* (see Appendix I) and facilitated some brief discussion on the *Desired Outcomes* for the meeting. The proposed Desired Outcomes by the LT were accepted. (see Appendix II).

The appendices include a listing of in person attendees as assigned to small groups and their facilitators (Appendix III). Several persons attended on-line.

The General Assembly was conducted throughout as a hybrid meeting, with live streaming of general sessions, and the opportunity for on-line participants to be put into breakout rooms for discussion when the in-person

meeting went into small groups. CCA contracted with Kevin Nelson for IT and live streaming services. Sr. Shirley Marie and Sr. Mary Fleig served to monitor the chat for any questions/comments from on-line participants. *Meeting Agenda* can be found at Appendix IV.

## Monday, May 5 at 9:00 am

Sr. Mary Fleig, OCD, opened the meeting and welcomed Sr. Nancy Schreck OSF of Dubuque Iowa who then offered the prayer and then her presentation. Her presentation was focused on Liminality. This was recorded and is available on the CCA members only section of the website. Nancy offered questions for discussions in small groups. Comments were shared in the large group. See Appendix V for *Day 1 Group Sharing*, Appendix VI for *Sister Nancy Day 1 and Nancy 2<sup>nd</sup> half of 1st morning* and Appendix VII for *Sister Nancy Day 1 afternoon*.

Eucharist was celebrated at 5 pm by Father Michael Berry, OCD in the Oratory. Sr. Robin had prepared a booklet for use at the Eucharistic liturgy each day. Sr. Bernadette Therese accompanied the hymns. Sisters had signed up to serve as Eucharistic ministers and lectors.

At 7:15 An informal gathering brainstormed on ideas for On-going Formation. See Appendix VIII *CCA ideas for how to do ongoing formation*.

#### Tuesday morning -May 6 at 9:00 am

Sr. Shirley Marie Ahern, OCD, opened the meeting and welcomed Sr. Nancy Schreck, OSF, who offered the prayer in the context of her presentation focused on Wisdom. There were small group and large group discussions/comments. See Appendix IX *CCA Day 2 morning* and Appendix X *CCA large group sharing* – *DAY 2 morning*.

# Tuesday afternoon - May 6 at 2:00 pm

The assembly gathered for a presentation by the five prioresses in regards to their work and completion of Goal 5: Each CCA community has adopted the protocol/practice of documentation in each of the areas as recommended by the task force and will have such in place within the next two years along with a process to keep current. Some of the prioresses used powerpoints and others simply addressed the questions/areas requested to be covered in a template provided to all of them.

After a break, Sr. Shirley introduced Sr. Mary Elizabeth, OCD of the Flemington Carmel. She is the North American representative on the International Commission formed to update the Constitutions. There are nine sisters on the Commission. The commission also benefited from the facilitation of Sr. Lidia Wrona who had been at the Nemi meeting. Sr. Mary Elizabeth's presentation was recorded and is available on the CCA website members only section. She noted that the work of the Commission to date has focused on the members getting to know each other, traveling to some of the sites established by St. Teresa of Avila, and developing a table of contents for the revised Constitutions. This table of contents will be sent out by July

1 with responses from the various federations/associations due back by Sept. 14. Going forward they will meet in person every 6 months. Notes on her presentation are Appendix XI – *Sr. Mary Elizabeth presentation*.

Eucharist was celebrated by Fr. Michael Berry, OCD in the Oratory.

In the evening at 7:15 there was general Q&A regarding with Sr. Mary Elizabeth regarding the work of the commission.

## Wednesday, May 7 at 9:00 am

Sr. Jeanne Marie opened the session and presented the prayer. She then turned the session over to the facilitator, Stephanie Hauge. Stephanie started off with recognizing the delegates, and then asking for the proposal regarding lifting the restrictions on the interest of the Kilduff fund be presented. (See Appendix XII 2025 Proposal -Kilduff interest). Stephanie clarified that the restrictions had been placed on the interest by the CCA not by the donor, therefore it can be changed by CCA. It was unanimously approved as requested and without modification.

Stephanie asked for the LT proposal regarding hiring an Executive Director be presented (Appendix XIII 2025 CCA Proposal Exec. Director). She then asked Sr. Marjorie to present the alternative to #3 of the LT proposal (Appendix XIV-Alternate proposal to No.3). Participants in the room and on line went to their small groups to discuss these proposals as well as any other ideas regarding the future functioning of CCA that they may have. Relevant suggestions were shared from the small groups in the large group. (Appendix XV - CCA proposals – discussions) Decisions were made (See Appendix XVI, CCA leadership Decisions) regarding hiring an ED, forming a Search committee (the LT plus Sr. Marjorie) and forming a CCA Governance Board (See Appendix XVII, CCA Governance Board) consisting of prioresses of the autonomous communities, plus Sr. Barbara, local superior of Cleveland and the following past presidents of CCA, Sr. Bernadette Therese (also a prioress), Sr. Colette, and Sr. Marjorie (also a prioress). The assemply reviewed in detail the ED job description (Appendix – XIII B- 2025 Exec Fir Job Description) that was provided to in conjunction with the ED proposal.

In the afternoon, discussion on simplification of the goals, and what priorities should be considered for each of them was held in small groups and leaders/secretaries of the groups were asked to provide their results to Stephanie.

The Eucharistic liturgy was celebrated at 5 pm with Fr. Michael Berry in the Oratory.

Wednesday evening at 7:15 – creative and fund games of CCA Bingo hosted by Sr. Mary Fleig.

#### Thursday May 8 at 9:00 am

Continuation of Business Meeting – Shared results of small group goal discussions and remaining to do's.

The meeting was opened by Sr. Rozalind. She offered the prayer and then turned the session over to the facilitator, Stephanie Hauge.

Stephanie acknowledged the work of the previous day sharing feedback on the goals (See Appendix XVIII *Simplification of goals*), and eliciting a discussion on the finalizing the goals and priorities (See Appendix XIX *Goals for 2025+ and priorities*,) a discussion ensued on what was missing... a vision. Sr. Connie offered to do a draft of a vision statement that would be shared with all at some point in the near future. (Appendix XIX B-*Discussion on CCA vision and other matters at GA*) In terms of the priority for Goal 3, how can we companion the non incardinated and other sisters? Susan Weber volunteered to ask who is doing what and who is willing to do something, or have ideas as to how to do this.

After finalizing the goals, the list of remaining to do's (See Appendix XX, Thursday's to do's). The CCA Governance Board was officially affirmed by the delegates. Their term would begin 9/1. The role of treasurer is open with Sr. Barbara Losh agreeing to continue for the next two months. The focus of the LT is identifying candidates for the ED role.

The meeting closed with recognition of those who had contributed especially to the success of the meeting, i.e., the members of the LT, Stephanie Hauge, Sr. Marjorie, Sr. Claire, Sr. Susan Weber, Sr. Denise Lyon, Sr. Miriam Hogan.

At 5 pm the Eucharistic liturgy was celebrated by Rev. Stephen Payne, OCD in the Oratory.

A concluding prayer service prepared by Sisters Marjorie and Sr. Marita Biscotti with recognition of the LT and new CCA Governance board was held at 7 pm.

# VI B. Nancy 2<sup>nd</sup> half of 1<sup>st</sup> morning

A story from your history

Connie,

The foundation of Antwerp and Hookstrackt, martyrdom was very characteristic of their mental state. Their parents had fled UK Henry VIII. Very conscious of martyrdom and how it influenced their lives. How did folks struggle through this.

First Carmelites that came to Europe, they had to adapt.

Move from Port Tobacco to Baltimore. Bishop Carroll had a rescript for the sisters to teach. They refused, because they supported themselves via the farming. Archbishop insisted that could not be supported by alms. The sisters taught for 20 years and it was non denomination. Anything to survive. The life wasn't destroyed.

Second Vatican Council 'Nuns federations and CCA itself.

It is our turn to be brave.

To foster the charism that is ours.

Keep ourselves grounded in the bigger story.

Part of the larger liminal shift 'Spirituality and long

What does this reality mean for contemplative life\_

#### For CCA

What would be some of challenges for living the contemplative life ' for the future

two facts of this for CCA 'Two pronged reality. 'We have a group of our sisters who are no longer living in monasteries... it is a facet of contemplative life today, what kind of strengthening could come from his situation.. because this is the reality.

The other part, where we are living in monasteries, gathering people around us for liturgies.. and sharing the contemplative life with younger people. There is a tendency to turn toward monasteries for what the young are seeking..

Hosting a group of young high school students.. he walked in a sacred space that helped him discern.

I was very encouraged that the diocese of Cleveland and Baltimore had people coming into the Church, as well as in England.. this could be a sign of hope

People who come for weekend liturgies, find peace. Priests like to celebrate because it is a place and space of faith and attentiveness to liturgy.

Students come to study and listen.

We need to be seen more broadly and not so many rules.

Our dispersed sisters are really important. Example of Sr. Thomas Acquinas while in a care center was a like a minister to the people, Sr. Mercedes, who was a source of joy to the staff. Bridge builders... not sure where the bridge is going.

Nuns and nuns... spiritually seekers... Meetings online, how do we exercise power, starting in philosophy, sisters and non sisters. Conversations...

Taking care of the earth... what is the spirituality that underlies this.

Out of the chaos, something new can come... Not data to lose hope.

Can we hold this time, in the larger world, and in our communities, that in there there is something

The reality is darkness, in which we may be the light.

In the beginning, the middle, and end, we work. Every sister needs to do the inner work.

This is a hard process. No excuse. The welfare of our communities depends on it.

Grace in the midst of liminality.

Grace is found wholly in the experience of liminality. We are being vulnerable in a society that values competence. Exalt in woundedness. Grace rarely comes as a gentle push to change. 'like a kick in the teeth'

Irony of the gospel is that the good news come from the bad news.

What happens in liminality we are shaken out of our complacency.

In biblical faith we are shaken out of our expectations. Think of the psalms..

God is never what Pharoh expects..

what you see is not what you get in biblical images...

Divine love is incessant. It turns woundedness into health.

In biblical faith, brokenness is not the end, but love on the way to completion.

Into the desert, out to the mountain

Jesus driven into the desert... ekballo, roughly thrown.. Jesus finds comforts and solace, Jesus going to places of abandonment. The desert, liminal space. In the desert the 5 thousand were fed.

We are drawn to the mountain.. difficult terrain.. Jesus is always leading people to the new. Luring people to a deeper understanding of who we are. Pushing the edges of our understanding.. This is place of transformation.

I am lavish with riches made from loss.

Make a new heart, make a new heart out of this experience.

Father Michael Berry had the experience of rotating with various monasteries in the Brighton area. Nuns were also teaching. The friars loved it.

Connie willing to do some recording talks on the history of our roots. When Jo Robson comes to our community, I intend to do some of the history with her and others. I would be willing to record it.

As long as I can do it, I am willing to do it.

Starting with Anne of Jesus coming to France, 1619 to now, history of almost all of the Carmels in US. Conflict over the constitutions! Amazing, how to overcome the divisions. Target date dependent on the move back into our cells hopefully fall of 2025. Break it up into sessions. At least four sessions.

Is there away to see the documents in the archives in the context of the discussions. Maybe one of the last sessions. A lot of the material is in our archives. When Chichester closed, the old archivist wrote to me to take the archives. The archives include Baltimore records and theirs.

WE need to be aware of defensiveness and desperation of energy in three ways;

- 1) emotionally overwhelmed
- 2) hyper intellectualization
- 3) move directly into action without consideration of consequences

When we don't know what to do, we need to understand if the containers are strong enough to hold new ideas. We have to trust mystery. The new can be assisted and emerging. Some things need to incubate for a while. We need to stay with suffering. Sometimes something new emerges.. something larger than us is acting. We begin to imagine preferred outcomes. There may be trouble, when we start the new, it is predictable that there will be a tendency to try to go back toward the familiar. Resist.

Being in the place of the new, it is hard to name how it actually happens. The new requires stepping into the unknown and the discomfort of finding emotional and behavioral responses that are different than where we began. We need to do our own inner work. companion each other in this process. Build relationships that can help the group to go into the new. Friendships help support the new.

Support the emergence of the new:

- 1. Inquiry and challenging certainty
- 2. Dialog
- 3. Consideration of the transcendent

Talk about CCA. What you hope for, describe CCA without using the word, how you would describe what you want for the future.

In flux, we are hoping that we can keep our friendship and hope for the future. I like the encouragement for prayer and contemplation. The joy of praying with others.

Wisdom emerges, something of the divine is at work. Fields of energy.. being surprised by the insight of others, two pronged.. emergence of something..

Emergent aspects of carbon, oxygen, hydrogen = sugar. But separately are not sweet.

Teilhard, the noosphere, and other examples. Jung's, moving forward protects the light from the wind, the shadow can bring a compensating balance. Have to pay attention to what is in the shadow. It can be destructive if we don't pay attention. Each of us individually, and in the group. Don't be so aggressive that you ignore the shadow. Bring it into the room.

Content with uncertainty and wonder

Probes and questions continue to reflect even after decisions are made.

You are not finished, sometimes we can't make a decision. Keep talking even when a conclusion is reached. Further conversation. How is it working??

This is hard, because we just want to know. Searching for knowledge... staying loose to the mysterious. Move collectively toward a more soulful way of being. Keep wondering about the mystery of it all.

**Subject:** Removal of "Restricted" Designation for the Kilduff Fund Interest Account

#### **Background Information:**

This fund was originally established to provide a stable source of interest income for CCA, to be focused primarily on programs. It was set up so that the principal could not be touched. Currently the interest in this fund is restricted only to programs and has been judiciously used for initial and ongoing formation as well as to supplement part of cost of some of our General Assembly programs. At this point in time the interest in the Kilduff fund has grown to be larger than the principal.

Current Funds (Acct103) Principal: \$42,000 Current Funds (Acct 302) Interest: \$61,426.15

#### Rationale:

As we look to the future of CCA, we anticipate that expenses for administration and operational needs to maintain the organization will only increase. This is due in large part to needing to hire outside people to take over administrative duties, and thereby relieving the members of the Leadership Team to concentrate on providing services and other programs that will benefit the membership.

#### Proposal:

We propose that the restricted status of interest from the Kilduff Fund be removed to allow the money to be used for operational and administrative purposes, as well as for programs, at the discretion of the Leadership Team.

**Subject:** Proposed "model/option" for the functioning of CCA during the next term.

# **Background Information:**

The future functioning of CCA as an association is uncertain, given the current reality of our CCA Communities, including:

- aging of all of our sisters
- lack of new membership
- diminishment of some communities
- · current status of five autonomous communities,
- stages of suppression for Concord and Barrington
- · affiliated status of Cleveland, Danville and Clinton

At the GA in 2023, the assembly adopted a goal to explore and propose options for the future functioning of CCA by the end of the current tenure (2025). It was further proposed at the 2023 GA to hold a discernment retreat for all members, which concluded with a final session on January 21. The Leadership Team listened to ideas and discussions from the participants regarding possible options and ideas. These have been taken into consideration with this proposal.

#### Rationale:

CCA's future is dependent on the future and vitality of its member communities. The challenge to obtain leadership from its membership has proved to be increasingly difficult. Just as each member community has been putting in place a realistic plan for its own future, CCA has been exploring options for functioning as it goes forward given the fragility of its current membership. The governance of affiliated communities has proved to be extremely time-consuming not only for the present Leadership Team but also for the two previous Leadership Teams. Several sisters of communities coming to final closure have been incardinated but not all. The care of these dispersed sisters and the financial burden associated with such has been challenging.

It is anticipated that going forward, the leadership of the CCA must address how the association will provide for its 1) financial requirements and responsibilities; 2) on-going formation; 3) care of the affiliated sisters who are not incardinated and are dispersed; 4) bring to final closure those affiliated monasteries that are still need to be closed/officially suppressed (Danville, Concord, Barrington and Clinton); 4) address the needs of its members as they arise.

# Proposal:

We propose that the CCA:

- 1) hire or contract with a part-time Executive Director (ED) to direct the administrative/operational responsibilities of the association for the two year term of the next LT;
- 2) continue to utilize the services of an Administrative Assistant (AA);
- 3) elect up to four sisters to a leadership team that has oversight of the ED, and that is supported by advisors/consultants consisting of at least two to three past CCA presidents;
- 4) continue to use the volunteer services of its current facilitator;
- 5) elect a treasurer who will continue to be supported by the services of BMT to manage its finances with oversight from the ED and LT.

In order to implement this proposal, the current LT will serve in a transition capacity until Sept. 1.

This proposal assumes that sisters from the member communities will serve in various delegated roles to support the Association's needs (e.g., the CCA newsletter, the CCA website, the CCA fundraising committee, coordinating formation, designated volunteer "companion contacts" to dispersed sisters, moderator of prioresses' meetings, etc.).

Description: The Executive Director (ED) is reponsible for all the business and administrative functions of the CCA. CCA is a non-profit association with membership of six autonomous communities: Baltimore, Boston, Carmelite Communion (NY), Cleveland (affiliated with CCA), Latrobe PA and Reno, NV. The ED is accountable to the Leadership Team. She has direct supervision and coordination of the CCA Finances (and its affiliated communities), its Treasurer and outsourced provider, Holly Borzacchiello, Health Care coordination for CCA sisters that are not incardinated, regular communications to CCA membership and in concert with the LT, contact for delegations as assigned, e.g., CCA newsletter, CCA archives, CCA fundraising committee, CCA on-going formation, CCA piroresses meetings, etc. She serves as an ex-officio but non voting member of the LT and the CCA GA. She coordinates and directs the work of the Administrative Assistant.

#### Responsibilities:

1. Affiliated communities.

Work with the member communities to identify and support companion sisters who are suitable to accompany the sisters who are not incardinated. These companion sisters would serve as sisterly companions and keep alive a connection with CCA and Carmel.

Work with CCA legal support, both canonical and civil to bring these affiliated communities to final completion and suppression. If the ED is a religious sister, she will function as the superior for the sisters who are not incardinated. In situations where there is an active local superior, she will support that superior as necessary. She will maintain effective oversight and coordination for the Health Care, Financial and support needs of these sisters and ensure that appropriate files with necessary directives are maintained and available.

Note: CCA has, as of this writing, 9 sisters who are not incardinated.

- Represent the CCA externally as appropriate and in consultation with the LT.
   This would include the OCD domestic and international associations/federations, the OCD Friars, the Generalate, CICSAL, the Internation Commission for the revision of the Carmelite Constituions, etc.
- Maintain effective comunications with the LT regarding important and extraordinary matters, while servicing the day to day regular affairs of the CCA.

# CCA 2025 PROPOSAL ALTERNATE PROPOSAL TO #3 of the Proposed "model/option" for the functioning of CCA during the next term.

#### BACKGROUND INFORMATION

Facing similar situations as CCA, communities in the U.S. are experimenting with models of governance that fit their present reality.

CCA's current membership is complicated, confusing, and shifting—autonomous, affiliated, sisters incardinated, closed monasteries, suppressed monasteries, sisters with unusual status, sisters in various phases of transition.

CCA is no longer an association of autonomous Carmelite Monasteries. It is both an association of autonomous monasteries and a communion of sisters—a sisterhood.

#### RATIONALE

A serious study of the current census of CCA's membership raises the question of holding elections at this time.

This is the smallest in-person participation at a national meeting in CCA's history, with 40+ sisters registered for zoom participation.

Rome seems very open to options or experiments that communities are choosing as they look to the future: various models of governance; new means of ongoing and initial formation; opportunities and options for the care of their members.

With fewer viable member Carmels, it is unfair to draw sisters from their communities into full-time leadership in CCA when they are needed in their communities.

Allowing ourselves to consider an "experimental" model of governance reflects the careful discernment and responsible functioning that has always been a characteristic of CCA.

It is important to have a means for handling sensitive situations, while guarding confidentiality, in an appropriate manner (with the ED).

#### **PROPOSAL**

#3 of the Proposal submitted by the LT reads: elect up to four sisters to a leadership team that has oversight of the ED, and that is supported by advisors/consultants consisting of at least two to three past CCA presidents.

# We propose an alternate to #3 of the Proposal:

We will not hold elections at this time but will choose an Advisory Group. The Advisory Group is made up of the prioresses and past presidents of CCA and will have oversight of the ED. The proposed Advisory Group is already a functioning group within CCA which meets regularly, with Sr. Susan Weber as moderator.

The sisters of the Advisory Group would function as a unit, sharing among themselves necessary responsibilities, experience, expertise, and requirements for CCA leadership. They will decide and choose who within the Group will carry out various roles.

#### Proposed role of the Governance Board.

The Board will provide oversight and support to the Executive Director in her role of directing and managing the affairs and needs of the CCA. They will determine her compensation, and review her performance. The Board will determine among themselves the strategic oversight roles each may serve as, e.g., Treasurer (oversight of the CCA accounting and cash disbursements). According to the adopted CCA Schedule of authorizations, the Treasurer's and or President's signature may be required on contracts and purchases. One of the Board members will serve as the President. She will be the official representative to the Generalate and to Rome. The Board will determine their need for meetings. The Board provides the overall strategic direction of the CCA in accordance with the vision, mission and goals of the CCA.
