Read, Reflect Renew

As part of our ongoing formation, CCA has embarked on a virtual discussion of the book *Religious Life for our World, Creating Communities of Hope* by Maria Cimperman, RSCJ. Sr. Kathleen Pruitt CSJP is the facilitator, and Sr. Maria, the author, will join us for at least two of the discussions. We have invited 73 English-speaking Carmelite sisters from around the world to participate in this program. Here is what Sr. Jenifer of the Varroville Monastery in New South Wales writes:

Long before it was fashionable to reach out across international borders (at least in the case of Carmelite communities) the CCA was issuing invitations to representatives of other Associations and Federations around the world to attend their Assemblies as observers. I remember the first invitation we received caused something of a stir. Our Association of Our Lady of the Southern Cross has member-Monasteries in Australia, New Zealand, Samoa, Wallis-Futuna, and Hong Kong. 'How could we possibly attend' we thought! It was like asking us to go the moon; it seemed so impossible. But thankfully the CCA persisted, and eventually we were able to attend an Assembly, and it changed everything for us.

Our latest venture is a book-sharing, with participants joining on ZOOM from USA, France, Netherlands, Scotland and Australia. We are reading Maria Cimperman's book, *Religious Life for Our World: Creating Communities of Hope.* One of the underlying premises of her book is the fact that together we can do more than we can alone. On that basis, even if all the English-speaking Carmelite communities connected with each other, we would create a very powerful network of Sisters across the world and a venue for sharing friendship, ideas, and possibilities.

Importantly, in our small way, it also witnesses to the

fact that there <u>can be</u> friendship and cooperation across international borders. In her book Cimperman quotes St Pope John Paul II who speaks of the Church as a communion of the faithful and that "her members can and must unite their efforts, with a view to cooperation and exchange of gifts, in order to participate more effectively in the Church's mission."

Thank you for supporting the CCA. It is a very worthwhile organization and one that continues to inspire and provide opportunities for our Carmelite way of life to deepen and grow.

CCA Elections

The CCA is pleased to announce the results of its recent election. Sr. Marjorie Robinson, OCD, of the Beacon, NY, community, previously serving as treasurer, has accepted the role of President of CCA.

The First Councilor is Sister Susan Weber, OCD, of the Reno, NV, community. The other Councilors are Sr. Mary Fleig, OCD, of the Baltimore, MD, community and Sr. Shirley Marie Ahern, OCD, of the Latrobe, PA, community. These sisters have assumed office immediately upon their election.

The outgoing Leadership Team of Sr. Bernadette Huang of the Boston, MA, community, (president) Sr. Rosalind Forrest of the Reno, NV, community, Sr. Monika Bies of the Baltimore community, and Sr. Cecelia Kang of the Reno, NV, community have been acknowledged with much gratitude for their generous and competent service to the CCA.

The Changing Role of CCA

In mid-2018 *Cor Orans* – the Implementing Instruction of the Apostolic Constitution *Vultum Dei quaerere* on Women's Contemplative Life, of the Congregation for the Institutes of Consecrated Life and the Societies of Apostolic Life – was issued.

The Carmelite Communities Associated's member communities are either affiliated or autonomous. An affiliated community is one that no longer meets the canonical criteria to be fully and really autonomous (*sui juris*). An affiliated community can affiliate with the association/federation of which it is a member, or it may, with mutual consent, affiliate with an autonomous community. Autonomous communities vote for a prioress (who canonically is the equivalent of a major superior), whereas affiliated communities have an appointed (by the president of the Association or prioress of the autonomous community with which they are affiliated) local superior. The affiliation is meant to be supportive and assist in determining whether the situation is temporary, whereby over time the monastery can become autonomous again, or whether the community will come to completion (suppressed) after all remaining sisters are transferred to care situations, if warranted, or to membership in a welcoming autonomous community.

CCA and its member communities have been engaged in understanding and implementing its directives. As a result, the CCA leadership can be selected by those member communities that no longer qualify to be completely autonomous to provide for their governance and thereby proactively assist in determining its path forward. This may entail various levels of support for such communities to transition to a smaller monastic home or independent living, and in some instances, sisters within these communities have been accepted into other communities, to assisted living, or continuing nursing care as the circumstances necessitate. This has been a very significant and difficult time of transition. In some instances, it means ultimately that a community must come to a final closure. CCA is a community of communities and, with compassion and hope, accompanies those of its members who are on this journey of discernment and decision.

As we seek to follow God's will for us, we have sought direction and sound advice to guide our decisions. In the spirit of St. Teresa, we respond with courage and openness, with a deep love for God, one another, the Church, and our Carmelite vocation. As Carmelites, the motivation for all our decisions is God's glory and the good of the Church.

The life of Carmel – seeking God in prayer and solitude – transcends the boundaries of walls and buildings. Although there is a sadness in endings, as Christians we believe that every ending promises a new beginning in ways we cannot imagine at present. We are a Paschal people. Christ's death and resurrection are the foundation of our faith and the assurance of our hope in God's care for us.

Shared Services Update - by Kate Asselin, GHR Grant Project Manager

Thanks to the continuing generosity of the GHR Foundation, implementation of the Shared Services Plan is proceeding with key service contracts recently negotiated in partnership with Christian Brothers Services (CBS) for: Financial Services; Benefits Eligibility Management Services (BEM); and IT Support and Website Services. These services are available to members of the Shared Services Collaborative (SSC) on a flexible, on-demand basis, individualized for each community, at specially discounted rates. Several communities have already engaged CBS for help with accounting functions, benefits eligibility questions, and IT systems problems and have been pleased with the services received. Other communities are working with CBS to redesign their websites or attending online educational programs like *Learning to ZOOM!* Most importantly, all these services allow the sisters to minimize time and energy devoted to administrative tasks and to engage more fully in their vocation to the Carmelite spiritual life. Expansion plans for the Collaborative are developing with other Carmelite communities and associations having inquired about SSC membership and available services. A growing list of SSC services is being compiled, and a video presentation on the Shared Services Collaborative is expected to be completed this fall.

On July 7, 2020 The Carmelite Institute of North America broadcast a virtual presentation of *The Four Waters in Word, Image, and Song.*




